The rolling rally starts in New Orleans and we will arrive in Tucson a couple of days before our pre-rally. Next stop Tucson! Registration is now available online for March 2020's FMCA's 101st International Convention in Tucson, AZ. Our chapter will hold our pre-rally at the Pima County Fairgrounds, the same location as the convention. We will arrive at the fairgrounds on the morning of Monday, March 23rd and we will stay on the same site throughout the convention which starts March 26 and runs through March 29. The FMCA will not charge us for the extra days. It does not matter what your preference for electricity or water/sewer is, we will have a designated location for our gatherings. We received the following announcement from the FMCA. *"FMCA's Executive Board has voted to withdraw from contract negotiations to stage the association's 102nd International Convention & RV Expo at the New York State Fairgrounds in Syracuse, July 29 through August 1, 2020.*

After many months of waiting to receive a contract for signature, the Executive Board determined that the time had come for FMCA to look for another location to stage this event. FMCA officials are currently busy vetting other sites for the association's 2020 summer convention and hope to have an announcement about a selected location in the coming weeks. We are sorry for any inconvenience this may cause members."

Our Eastern Coordinator, Jean Borin and her husband Bruno are to be commended for planning ahead! I know that most of us want to make plans a year or so in advance and Jean & Bruno have been working on Syracuse since July when they were informed that destination was a certainty. Their plans include a rolling rally starting in Gettysburg and making two stops in New York. There was a lot of immediate interest in this rolling event and within a few days of our last newsletter Jean quickly found herself negotiating for additional sites in the Gettysburg and Marathon, New York campgrounds. Following the FMCA announcement that we are not going to Syracuse Jean polled the families that had expressed an interest in the rolling rally and found that almost all of them had already made their reservations. The response was overwhelming to continue with our rolling rally plans even though the Syracuse convention was cancelled. Jean has added another stop in upstate New York, and we are looking forward to the adventure! The schedule for these events is:
