Item number three.... I am going to ask for a change in the by-laws. This requires a notice be given, so consider this the notification. This also requires a majority vote on the floor of the attendees.

1. I move we terminate term limits for officers of the Chapter. The reason for this is because we are violating this requirement now and have in the past. It seems there is no requirement for this by-law as we can't get anyone to fill the office as it is!
2. I move we have another class of membership in the chapter. This will be an Associate Membership. It would include anyone that has owned an American coach in the past and for some reason does not own an American now, but would still like to come to the rallies and be with friends. This membership would have all of the rights of the full membership except they would have no voting rights and they would not be eligible for service from the factory service team. This is the gist of the new membership and details will be worked out by the Board of Directors.

I have been in contact with other Chapters and they have adopted this type membership and it has worked out very well for them.

Please let me know if you would like any other changes that you would like introduced. It is your Chapter and we want it to have everything that will make it more exciting for members....
