The current balance in the checking account as of 4/24/14 is \$9,278.23.

The current balance in the 11 Mo Risk Fee CD as of 4/24/14 is \$14,213.15.

We have 270 members total and 37 of these members are delinquent in their dues. We're working on getting them to renew.

A few reminders....

American Coach Chapter (ACC) membership dues expire December 31st of every year; Even if you pay multiple years, it will always be December 31st. It's more cost effective to pay multiple years.

If you or anyone you know needs to makes changes to their names, mailing addresses, email addresses, or phone numbers, PLEASE email or call your ACC membership contact person so we can keep our website up to date.

About 60 % of all ACC members use PayPal to pay their dues and update their contact information. Our Website requires you fill in your contact information. The other 40% of you write checks for your dues and we never get any updated contact information on you. Often

## Duties of ACC of FMCA Board Members

The **President** will be responsible for setting goals and making sure the chapter is financially sound.

The President shall secure sites for rallies after finding out from the FMCA director where the FMCA conventions will be held. The sites shall be determined using the "campground selection guide" and shall be secured at least 2 years before the date of the rally, unless the date is not available from the FMCA.

The President shall assist the area directors in any way possible in setting up the rallies in their area.

The President shall seek door prizes and sponsors for individual events at the rallies.

The President will work with the American Coach representatives, service and sales to coordinate the rally.

The **Vice President** shall assist the president in any duties of the President and fill in for the president when the President is not available.

The Vice President or the rally master shall receive the rally registrations for the rallies and register the members. The Vice President will work with the area director and keep him informed of the number of registrations for the rally.

The Secretary shall take minutes of the meetings. The secretary shall keep the FMCA informed of the chapter membership and other specific duties that will be determined by FMCA.

The Secretary will keep the history of the club for reference. The Secretary will write letters of invitation and send the current newsletter to prospective members as notified from FMCA.

The **Treasurer** shall keep the books of the chapter using the chapter copy of Quicken.

The Treasurer shall keep the President informed of the status of the chapter at all times and if there is a sudden change in the financial position of the chapter.

The Treasurer shall use the Bank of America, unless the Executive committee decides to change the bank that the chapter is using.

The Treasurer will write the checks for the rallies and reimburse the rally master for expenses incurred, upon presentation of actual receipts.

The Membership Chairperson shall keep the membership database updated and register new members.

The Membership Chairperson shall send a copy of the membership database to the President on a monthly basis and keep the president informed of all activities.

The Membership Chairperson shall order and deliver to new members their name badges.

The Membership Chair shall send out dues notices and receive dues from members. The dues shall be deposited in the bank and the Treasurer notified.

**Area Directors** shall receive from the President the site location of the rally as soon as it is determines and will start to set up the rally. The Area Director will work with the President in determining the price of the rally and the activities for the rally, but the overall planning and execution of the rally shall be the responsibility of the Area Director and he or she will be called the Rally Master.

## Vidalia Onions Released April 21st!

Vidalia Onions, the sweetest onions in America, are the only onions in the United States to have their own designated growing area (in Georgia) and their own release date.

I have been making this onion pie for over 15 years and I buy the first Vidalia Onions just for this.

## Deep-Dish Vidalia Onion Pie

#### Crust

1 envelope active dry yeast
1/4 cup luke-warm water
1/4 tsp sugar
1/3 cup milk
2 Tbsp unsalted butter
1 tsp salt
1/2 tsp caraway seeds
About 2 1/2 cups all-purpose flour

## **Filling**

2 Tbsp unsalted butter
4 medium-large Vidalia Onions, cut in
to 1/2 inch dice (about 3 cups)
1 1/2 Tbsp all-purpose flour
1/4 cup milk
1/4 tsp salt
8 oz cottage cheese
3 eggs

### Make the crust:


- In a small bowl, dissolve the yeast in the water with the sugar. Let proof until foamy.
- In a small saucepan, heat the milk butter salt and caraway, stirring until the butter almost melts.
- 3. Pour the liquid into a large bowl.
  Stir in 3/4 cups flour, then the
  yeast mixture. Stir in 1 cup more
  flour, then knead in however much


more flour is needed to make a soft dough. Turn the dough out on a floured surface and knead until it is medium-firm, smooth and no longer sticky, adding flour as needed.

 Place dough in a buttered bowl and let rise in a warm place until doubled in bulk, about 1 hour.

## Meanwhile make the filling:

- In a large heavy skillet, melt the butter over low heat. Add the on
  - ions and cook, stirring frequently, until the onions are golden and soft (do not brown the onions).
- 2. Add the flour and cook for 2 minutes. Add the milk and salt, increase the heat to





- 4. Preheat the oven to 375. On a lightly floured surface, roll out the dough to form a rectangle slightly larger than the baking dish. Butter the dish and press in the dough to extend about 3/4 up the sides. Pour in the onion filling.
- 5. Bake in the center of the oven for 45 minutes or until the crust is nicely browned and the filling is golden brown. Let cool in the pan for 15 minutes, then gently lift out the pie and let cool on a rack before cutting into serving pieces.



## The International Traveler

**Don't trust over-the-counter drugs.** They are like a box of choco-lates. You never know what your are going to get. Carry these basic over-the-counter drugs: antacids, anti-diarrheal, sunscreen, cough and cold medicine, hydrocortisone cream, motion sickness, antihistamines and insect repellent.

If you are going to a sunny locale, ask your doctor if any of your prescriptions cause sensitivity to the sun. Many of them do!

Create a simple medical information form to carry with you. It should contain your name, address, phone, friends and relatives to contact in an emergency, personal physician, dentist, current medications, known food and drug allergies and full information on medical insurance.

**Ask friends who have recently visited your destination** what they wished they had taken with them. Facebook or Instagram is a good place to do this.

Know that Medicare will not cover you outside of the U.S., Canada or Mexico. And, Medicare will only pay to get you to the nearest hospital, regardless of how inadequate that hospital may be—Anywhere else will be at your expense.

**Take along more prescription medication than will be needed.** An extra week's supply is a good rule.

Ask your doctor for duplicate prescriptions in case your pills are lost or stolen.

Put pills in your carry-on—not your checked luggage.

**Adjust your schedule of prescriptions to account for time zones.** A second watch with local time might help.

If you are susceptible to motion sickness, the best location on a ship is mid-ship and the best in an aircraft is over the wing.

The seven top triggers of diarrhea are custards, pastries and desserts, raw vegetables, raw eggs, and unpasteurized cheeses, tap water and ice cubes made of tap water, leafy green vegetables, raw shellfish, and raw meat.

The best medicine for traveler's diarrhea is Imodium AD.

**Shake your sunscreen well** as the ingredients are suspended in a neutral lotion.

The strongest sunscreens are made with either Americaine or Dermoplast.

Apply meat tenderizer to bee and bug bite to reduce the pain and swelling.

**Avoid sunstroke and dehydration** by eating bananas, tomatoes and oranges, which are all rich in electrolytes in addition to plenty of water.

**Never wear new shoes when sight-seeing.** It's a sure way to get blisters.

If you take nitro for your heart, make sure your pills are fresh—they lose potency over time.

**If you take insulin, carry a prescription for your syringes.** Many states and countries will not sell them over the counter.



#### **American Coach Service Request**

Fleetwood RV is offering to perform minor warranty repairs on your Limited, American Eagle, American Dream, American Tradition, American Allegiance, American Revolution or American Heritage motor home. Time available and the number of coaches in attendance will determine how much service work can be performed at the rally.

Please check in with the service representative scheduler upon arrival. He may need to coordinate your appearance while service is performed.

Please limit problems to two American Coach items and one Spartan item per coach (functional items only). Nonfunctional items and painting will not be addressed at rallies. This is a long-standing policy of the service facility. Additional items will be on a time-permitted basis.

Please explain each item in detail so we can determine whether parts are needed.

Submit this list promptly. Fleetwood must have your request at least two weeks before the rally in order to obtain parts and transport them to the rally.

Repairs will be scheduled in the order that they are received.

Add-on items will be scheduled as time permits.

When requesting chassis repairs, pleas note your coach type of chassis. Some chassis repairs cannot be addressed at the rally and some chassis repairs may be subject to charges to the customer.

Note: Coaches not registered, as part of the rally will not be worked upon until all rally registered coaches have been serviced.

### Here are some of the changes:

- Parts and labor will be provided at no charge for in-warranty repairs. Labor will be provided at no charge for out of warranty repairs and owner will be notified of charges for parts.
- Because we are not equipped with required fall-protection at rallies, no Fleetwood associate will be allowed to get on top of a motor home roof at any time.
- No Fleetwood associate will be allowed to work under a unit at a rally.
- Repairs requiring lifting/jacking of motor home will not be performed at a rally.
- Certain repairs of doors or windows or windshields cannot be performed at a rally.
- Awning tension adjustments must be done by the awning manufacturer. This includes the replacement of awning fabric.

Chassis repairs must be done by the chassis manufacturer.

## As has always been our policy, the following are some other items we cannot address at rallies:

- Paint body repairs
- Installing accessories
- Cosmetic/Appearance repairs
- Water filters and maintenance services

Please remember that not every problem can be resolved at the Rally. Should additional work be required at a shop facility, the Service Department will assist you in determining your needs and schedule.

## Become a Part of Something Fun!

#### **FAQS about ACC**

**Q.** What is the difference between the ACC (American Coach Chapter of FMCA) and ACA (American Coach Association)?

A. All members are owners of American Coach motor homes. The ACC is a chapter of FMCA (Family Motor Coach Association) and you must be a member of FMCA. The ACC has two pre-rallies a year so they may caravan and park together at the FMCA International conventions. Members of ACA do not need to belong to FMCA and are independent from any other membership group. ACA has two national rallies a year and has eleven regional chapters.

**Q.** Can I be a member of both ACC and ACA?

**A.** Yes, most American Coach owners are members of both organizations.

**Q.** Why do I have to be a member of FMCA in order to join the ACC?

**A.** FMCA by-laws require that members of a chapter also belong to the national association.

Q. What are ACC's roots?

**A.** The ACC was started by ACA members that wanted to park together at FMCA events and had their first rally in Gatlinburg, TN in 1993.

**Q.** Are the officers in ACC paid?

**A.** No, they are volunteers and only out-of-pocket expenses are paid.

**Q.** Do I have to be an original owner to have the American Coach service team work on my coach at the rallies?

**A.** No, qualifying service is available to all American Coach owners attending a participating rally.

American Coach Chapter of FMCA consists of members that are owners of an American Coach including American Heritage, American Eagle, American Dream, American Tradition, American Revolution and Limited Motor Homes.

We are the only American Coach chapter of FMCA and provide our members with camaraderie with other American Coach owners. Our primary goals are to foster good relations with the American Coach manufacturing and servicing facility. We bring its management, their technicians and coach owners together.
